Forensic Science is the study and application of science to matters of law. In other words, you'll learn about using science and scientific methods to investigate crimes and examine evidence that may be presented to a court of law,

Forensic Science is more than "just science". It combines everything you learn in school in ALL your subjects. Here's a sampling of evidence:

- Math graphing, statistics, ratios, measuring, word problems...
- <u>ELA</u> research skills, oral and written communication, technical reading skills...
- Social Studies criminal justice, constitutional rights, forensic history, law...
- Technology microscopy, computers, photography, chromatography...
- Process Skills interviewing, problem solving, organizational skills...
- Earth Science casts and molds, mineralogy, soil studies...
- Chemistry density, fire and explosives, mixtures and separations, toxicology, ...
- Physics light, sound and voice patterns, trajectories...
- <u>Life Sciences</u> serology (blood, DNA), anatomy (fingerprints, bone, hair, teeth)...
- More! cosmetics, handwriting, forgery...

I wasn't kidding! You'll use all the knowledge you've learned in school and in daily life to investigate and solve crimes, then use your results to present your case to a judge and jury.

It takes a team to investigate crimes. Each CSI (Crime Scene Investigator) specializes in an area of forensic science. Their workplace can be at the scene of a crime, in a crime lab, or in their specialty lab.
